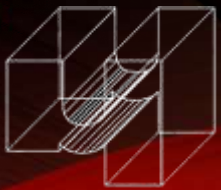

What is it?



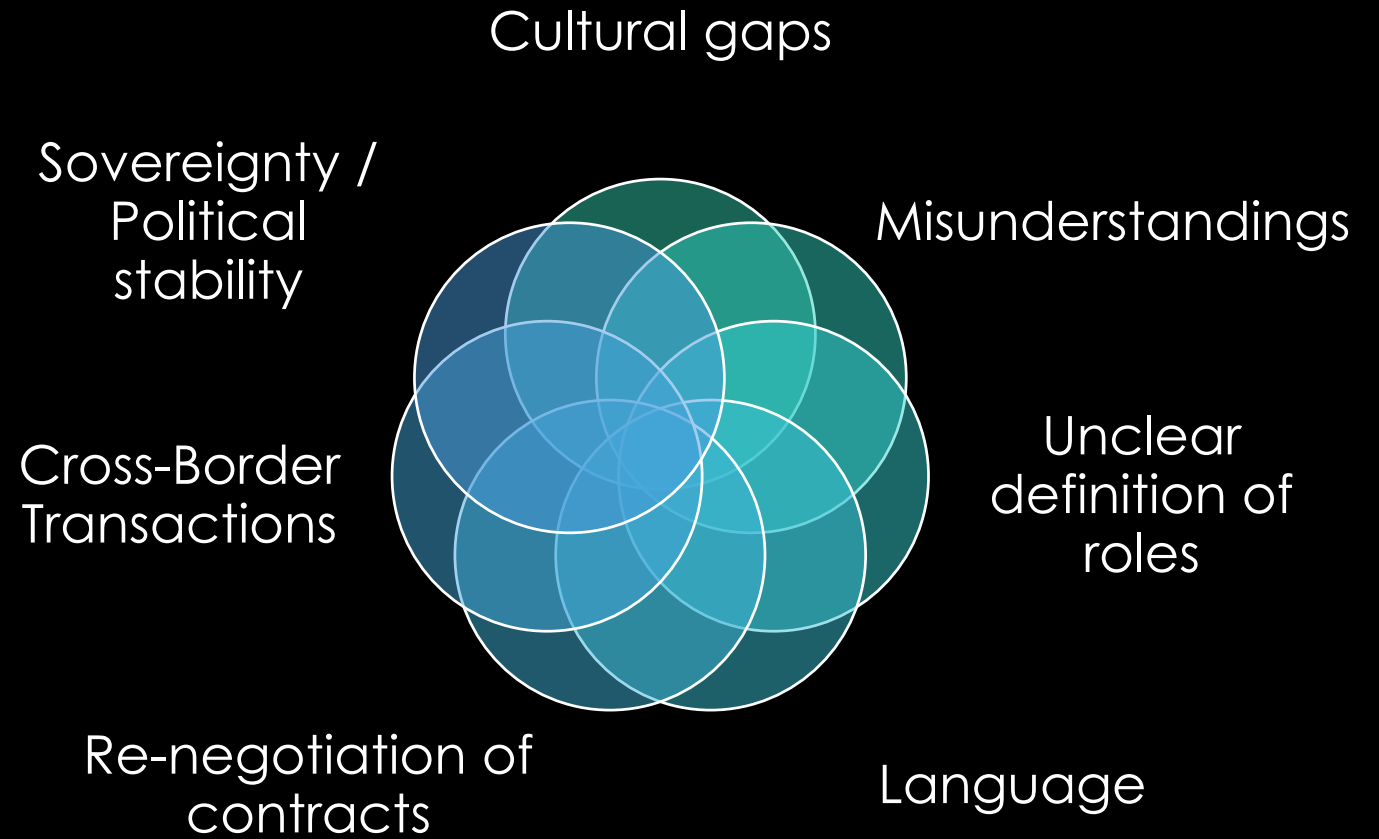
## THE YLRM PROGRAM IS:

- An effective way for clients to commence relationship

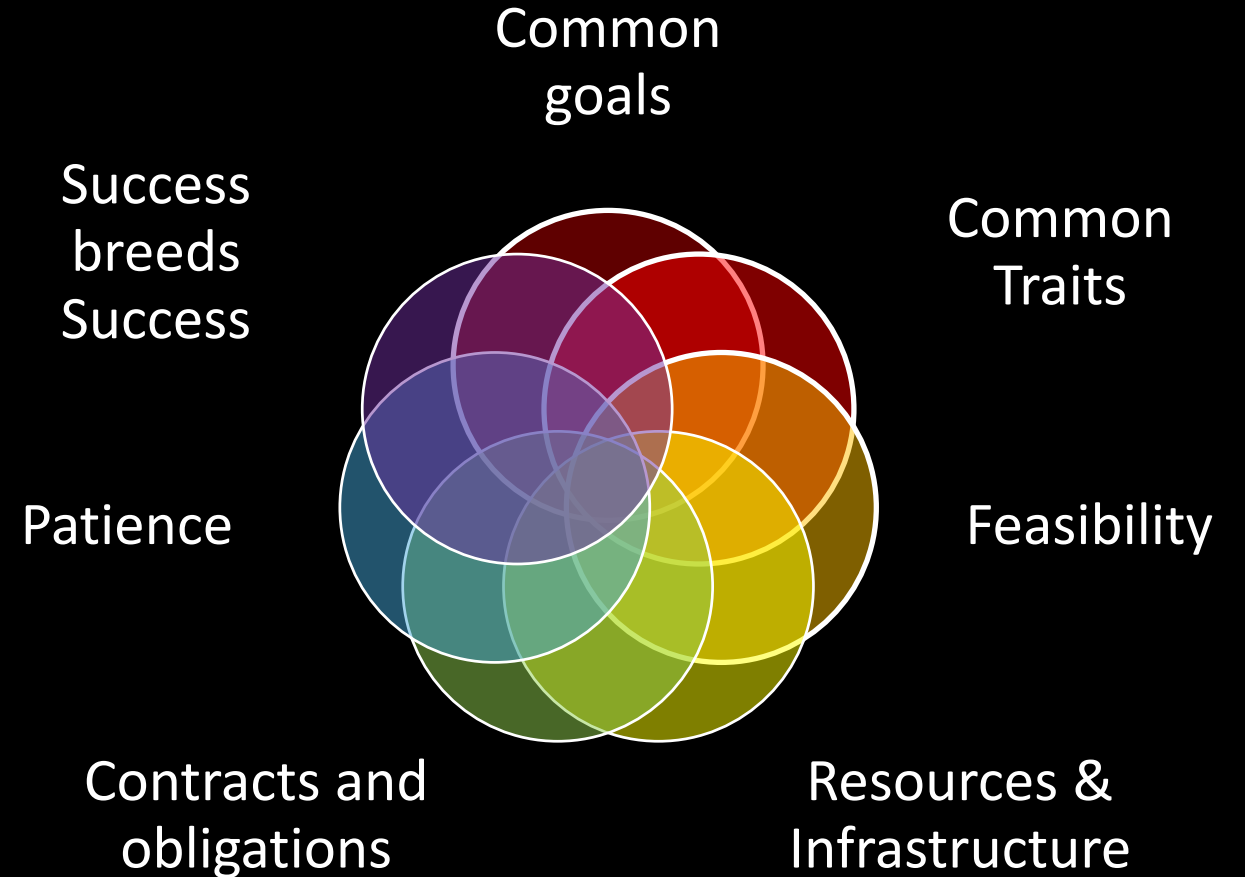
## THE YLRM PROGRAM IS NOT:
